#### **Discussion on Role and Remit**

A draft terms of reference on the role and remit of the Forum was handed out for discussion. Those present agreed it was, in principle, fit for purpose with the addition of a reference to service users. A revised paper will be sent out to members for further comment. The edited version of the terms of reference will be proposed for acceptance at the next meeting on the 5<sup>th</sup> September 2014.

Action Joanna Clark: To edit the draft terms of reference to reflect feedback.

Action Christine Davison: To distribute to the membership for feedback.

### **Fife Council Funding Review**

The current funding review affects around 220 organisations in Fife. Fife Council is looking to achieve savings of between 5-10% (£1.5 Million) but current information is that this will not be an arbitrary cut across the board. Fife Voluntary Action is hosting 14 separate funding review workshops over the next few weeks (for detail see: <a href="http://www.fifevoluntaryaction.org.uk/news.asp?id=4908">http://www.fifevoluntaryaction.org.uk/news.asp?id=4908</a>) in order



to co-ordinate a proactive response from the sector and feed into this review process in a timely manner.

A workshop event is provisionally scheduled for 29<sup>th</sup> September 2014 with Fife Council followed by a paper that goes to committee at the end of October 2014, necessitating the tight timeframe for gathering responses. Any organisation may respond individually and/or collectively.

Kenny fedback on the launch event for the funding review he attended on 20<sup>th</sup> June where three key subjects were discussed: recurring Grants, discretionary rate release and assets, leases and premises. No solid conclusions were drawn.

Kenny also referred to the potential for efficiencies and savings that might be gained from the voluntary sector hubs which are currently being explored with Fife Council.

Consensus emerged from members that the sector needed to better articulate the additional funding brought to Fife through the third sector (tied to the core funding from the Council), which if lost may have a considerable impact of the services delivered by the sector. Equally important was articulating the time, skills and goodwill of volunteers associated with both core funding and linked additional funding that would also be lost as a consequence of cuts.

Kenny also reminded the Forum about a financial climate survey that had been posted by FVA on our website prior to the announcement of the review; which it was agreed would be re-published and advertised and if the response was sufficient would be a useful tool to collate a statistical sectorwide response.

Action Christine Davison: To distribute a link to this survey to the forum.

#### **Integration Update**

#### A. Shadow Board:

Kenny fed back on two key items from the recent Shadow Board meeting:

- Fife's response to the draft regulations published by the Scottish Government. This included a list of services included and not included in integration, membership of the new board and voting rights. (for list see Stephen Moore's Presentation at the First Health and Social Care forum: <a href="http://www.fifevoluntaryaction.org.uk/downloads/03.07.14smpresentation.pdf">http://www.fifevoluntaryaction.org.uk/downloads/03.07.14smpresentation.pdf</a> slides 6 and 7) The third sector has a place on the Shadow Board in Fife but no voting rights.
- Discussion on the Joint Commissioning Strategy. We expected to see a draft come out to consultation in the next couple of months for implementation in 2015; however a number of partnerships across Scotland expressed concern over the timescale, so the Scottish Government has extended the deadline by 12 months (now April 2016). In Fife a lot of work has already been done on a Joint Commissioning Strategy, which The Shadow Board has requested an update on for the next meeting. The full Strategic Plan (which will include what was known as the Joint Commissioning Strategy) should be out for consultation in Summer/Autumn 2015 with implementation from April 2016.



#### **B. Integrated Scheme:**

The next key date is the 23 September when the consultation of the Integration Scheme will be released. The Integration Scheme needs approval from the Scottish Government. It will set out the governance and management of the integrated body and how it will operate.

Organisations can respond individually or collectively as the Health and Social Care Forum.

- C. **Meeting with Sandy Riddell**: Kenny met with the new Director of Health and Social Care, Sandy Riddell who starts on Monday 01 September. Initial impressions were positive; Sandy seems keen to engage with the third sector. We will invite Sandy to the Forum later this year.
- D. Integration Fund: Fife's share of the £100m Fund is £6.73million. The 4 year Reshaping Care for Older People (RCOP) fund comes to an end in March 2015. The Integrated Care Fund builds on the RCOP Change Fund but should not simply be used to support existing initiatives previously funded through their RCOP Change Fund. To date there have been no discussions around transition of services. Kenny has raised concern over the potential loss for third sector services, skills and projects.

There have been no conversations on how to use this Fund. The Forum has the opportunity to feed into these discussions.

# E. Organisational Development Money (OD):

£15,000 (out of a total of Organisational Development Fund of £469,000) has been jointly allocated to the third and private sector.

Kenny has proposed the creation of an integration post within Fife Voluntary Action would be the most beneficial use to the sector; however this requires additional funds to be allocated by the integration team and agreement with the private sector partners. There was support for this proposal within the Forum. Forum members had no other suggestions for use of these Funds and are keen to see the FVA proposal accepted.

All Organisational Development opportunities will be made available to all sectors, and so third sector staff can access this support alongside public and private sector colleagues hopefully bringing the opportunity for cultural exchange; and equally are encouraged to suggest ideas to add to the OD plan.

#### F. Referendum Debate:

Fife Voluntary Action and Scottish Care have organised a debate on the Scottish Referendum with a focus on Health and Social Care. Attendees will have the opportunity to hear from, and question, speakers from the Yes and Better Together campaigns.

The Debate is at Rothes Halls, Glenrothes on Wednesday 13<sup>th</sup> August and starts at 4.30pm.

### **Health and Wellbeing Alliance**

The Alliance recently went through a review of their purpose.

Through this review they have determined that they are no longer a body that delivers but instead an influencer. They are restructuring and developing a new strategic plan; more



information on this will be disseminated to the Forum along with information on the Alliance itself.
